In compliance with the MCA Circulars and SEBI Circular dated October 3, 2024, the Annual Report of the Company for the financial year 2024-25 including the Notice was sent through electronic mode to equity shareholders whose email address is registered with the Company / Share Transfer Agent of the Company, MCS Share Transfer Agent Limited ("MCS") / National Securities Depository Limited ("NSDL") / Central Depository Services Limited ("CDSL") / Depository Participant(s);

Annual Report of the Company for the financial year 2024-25 including the Notice was also placed on the website of the Company at www.surajgroup.com and on the website of the Stock Exchanges, i.e., BSE Limited at www.bseindia.com; NSE Limited at www.nseindia.com and on the website of Central Depository Services Limited ("CDSL") <https://www.evotingindia.com/>.

The Company had availed the remote e-voting facility offered by Central Depository Services (India) Limited (CDSL) for conducting remote e-voting by the Shareholders of the Company and e-voting at the AGM by electronic means.

The voting period for remote e-voting commenced on Sunday, July 06, 2025 (9:00 a.m. IST) and ended on Tuesday, July 08, 2025 (5:00 p.m. IST) and the CDSL e-voting platform was disabled thereafter.


